Ken Tulloch – South River Road

- Concerned about road conditions on South River Road
- Maintenance has been sporadic over the years and there has never been a full reconstruction
- Driving has become problematic
- This has been a long term concern
- Mr. Tulloch tabled a letter and photographs of the area – letter is co-signed by many area residents
- Council assured the delegation that this road was a priority and pending the tabling of the Roads Study Council had every confidence that this road would be worked on this year

Bonnee O’Neill – Shannonville Agricultural Society

- Several volunteer work bees have taken place to clear the western area of the recreation complex of trees and brush
- This was the work that the SAS brought forward a few months ago
- The SAS asks the Roads Supervisor to clear the area so that it is leveled and usable

- The SAS would like to apply for a Trillium Grant to purchase bleachers, picnic tables, tables and chairs and garbage cans
- These purchases will also be a benefit to the Township
- The SAS asks for Council support via motion to proceed with a Trillium Application with the Township as a partner
- SAS is asking for approval in principle to support the application first and the project purpose second

WHEREAS The CN crossing in Tyendinaga Township at Mowbray Rd has been a safety concern for many years AND WHEREAS Council decided by duly carried by-law 04-24 on September 20, 2004 to close this crossing due to safety concerns

AND WHEREAS the CN crossing closure took place in the fall of 2006

AND WHEREAS the southern portion of Mowbray Road is now inaccessible from the northern portion of Mowbray Rd

AND WHEREAS the portion of Mowbray Rd to the south of the tracks is now more closely associated with Mowbray's Rd on Tyendinaga Territory as a through road

AND WHEREAS concerns have been brought forward in relation to emergency 911 access to this southern portion, south of the tracks

THEREFORE BE IT RESOLVED that the portion of Mowbray Rd south of the railway crossing closure to the southern border of the Township be henceforth known as Mowbray's Rd

BE IT FURTHER RESOLVED that this name change will allow 911 dispatch to alert emergency vehicles that access to this portion must be from the south

BE IT FURTHER RESOLVED that this name change be communicated to all 911 interests

AND BE IT FINALLY RESOLVED that this road name change is wholly intended to be a safety measure so emergency access is not compromised.
