**Mike Bossio – Wyman Bridge**

- Firstly, congratulated Council on receiving the \$1,150,000 for the Wyman Bridge secured through a proposal to the Ontario government sponsored Municipal Infrastructure Investment Program
- Has questions and concerns to convey to Council in relation the Wyman Bridge project
- Is the design in keeping with the Councils vision for the Township?
- Is concerned that we are tearing down a bridge, built in 1922, with heritage value to the Township
- Very few of these pony bridges exist anywhere, and shouldn't some measures take place to protect this one?
- What other options were considered?
- What message does the Township wish to convey for the future?
- Wasn't rehabilitation considered in order to retain the integrity of the old bridge?
- John confirmed that the last time this 1922 bridge had significant work was in 1996
- Malcolm and Mike had spent some time at the bridge to ascertain speed and volume
- Felt that people actually slowed down on approach and that the traffic count was not very high
- The comparator used was the Waddingham Bridge
- The delegation had a couple of technical questions for our engineers who were in attendance
- The questions centered around costs and alternative designs
- Councillor Phillips interjected that it was not the engineers who need to defend a decision of Council and that the dialogue was starting to break down
- Mike concluded by asking if the Council had any appetite to open up discussion and review the design of the bridge
- Council did not want to revisit the design and was confident that they had made the best decision based on engineering reports and available financing
